3. That the school management will ensure that the teaching and non-teaching staff are paid salary and other allowances at par with the CBSE and non-compliance of this condition will result in re-calling back 'No Objection Certificate'.
4. That you and your school management will ensure that any information if desired by the Distt Education Officer or Department of Education or any senior officer, such information will be given to such officer and full co-operation will also be given to him/her.
